**Showcase Rules:**

1. Applicants must be age 17 and over who have not professionally or publicly presented more than 5 works, and who live, work or attend school in Fairfax County Virginia.
2. Choreography can be any dance genre and limited to between 3 and 6 minutes.
3. The piece being presented should not have been previously performed and must have between 3 and 15 dancers.
4. The video of your piece should have correct costuming and show the work straight on in its entirety.
5. The lighting does not have to be exact, but a description of the lighting must be included on the entry form.
6. Deadline for submission of your complete application is Wednesday, February 15, 2012. Applications postmarked by February 15, 2012 will be considered submitted on time.

**Showcase Availability:**

1. Choreographers chosen to participate in the Showcase will be notified by March 15<sup>th</sup> 2012.
2. Choreographers chosen to participate must be available to perform at the Showcase on April 15, 2012.
3. One piece of choreography will be chosen by the professional members of the Fairfax County Dance Coalition as the best in the Showcase.
4. The winning showcase choreographer will be awarded \$500.00 and the piece must be available to be performed at the Fairfax County Dance Coalitions 3<sup>rd</sup> Annual Dance Gala on October 6<sup>th</sup> and 7<sup>th</sup>, 2012.
